REGULAR MEETING

Vice Mayor Chu opened the regular meeting at 6:30 p.m.

1. Councilmember Chu reported that the Marin County Council of Mayors and Councilmembers' Pension and Other Post Employment Benefit Reform Committee has met for sixteen months and the final report should be available to the public in May 2019.

7. PUBLIC HEARINGS

7.1 WAIVE FIRST AND INTRODUCE ORDINANCE NO. 1039 TO ADOPT A NEW "WIRELESS COMMUNICATIONS FACILITIES" CHAPTER, LARKSPUR MUNICIPAL CODE (LMC) 18.51, AND CONSIDERATION OF A RESOLUTION ADOPTING POLICIES, PROCEDURES AND PROCESSING REQUIREMENTS FOR SMALL CELL (5G) WIRELESS FACILITIES

Senior Planner Kristin Teiche reported on proposed Ordinance 1039 and proposed Resolution 19/19. The proposed ordinance, titled Wireless Communications Facilities, incorporates updated federal and state regulations and definitions, and provides more detailed submittal, locational and processing requirements. The proposed resolution adopts policies, procedures and processing requirements for small cell (5G) wireless facilities.

Vice Mayor Chu opened the public hearing.

Public comment was received; staff responded to comments. Vice Mayor Chu closed the public hearing.

Upon motion by Councilmember Hillmer, seconded by Councilmember Haroff, Council waived first reading and introduced Ordinance 1039, and took no formal action on Resolution 19/19. Ordinance 1039 will be brought back to Council for a second reading on April 17, 2019; Resolution 19/19 will be brought back to Council on May 1, 2019. The vote was three in favor, two absent.

7.2 WAIVE FIRST READING AND INTRODUCE ORDINANCE No. 1038 REPLACING LARKSPUR MUNICIPAL CODE (LMC) 18.23, AMENDING ZONING REGULATIONS FOR ACCESSORY DWELLING UNITS TO COMPLY WITH STATE LAW

Planning Director Neal Toft reported on the proposed Ordinance that will amend regulations for accessory dwelling units to comply with State law.

Vice Mayor Chu opened the public hearing.

Public comment was received; Planning Director Toft responded to comments.

Vice Mayor Chu closed the public hearing.

Upon motion by Councilmember Hillmer, seconded by Councilmember Haroff, Council waived the first reading and introduced Ordinance 1038. The vote was three in favor, two absent.
