**Appeal Period:** The Heritage Preservation Board is an advisory body and will provide a recommendation to the City Council, Planning Commission or Zoning Administrator. The City Council, Planning Commission or Zoning Administrator will hear applications during a publicly noticed meeting. Any final decision of the Planning Commission or Zoning Administrator may be appealed by submitting an appeal form and fee to the City Clerk within 10 days of the final decision.

**Availability of Documents:** Any writings or documents provided to a majority of the Heritage Preservation Board regarding an item on this agenda will be made available for public inspection at the Planning Department at City Hall located at 400 Magnolia Avenue, Larkspur, CA and at the main counter of the Library located at the same address during normal business hours.
